



he West African Research and Innovation Management Association(WARIMA) has paid a courtesy visit to the National Headquarters of the Joint Admissions and Matriculation Board (JAMB), Bwari, Abuja.

WARIMA is a non-profit professional membership organisation for research managers and administrators across West Africa.

The WARIMA delegation was led by its President, Mr. Dembo Bakary Kanteh, and was accompanied by the former President, Prof. Labode Popoola, and other members to the Board on Monday, 10th July, 2023.

He stated that the visit was in partial fulfilment of its desire to continuously develop, engage in research and innovation management in the subregion to facilitate knowledge-based activities, inventions, interventions and solutions that will unleash sustainable development in West Africa.

According to Mr. Kanteh, the mission of WARIMA was to formally inform the Board of its intention to hold one of its training workshops in Nigeria, and to seek the Board's support for the

2023 UTME REGISTRATION INFRACTIONS: SUSPECTS DENIED BAIL ...As JAMB Recounts How They Were Apprehended

Pour suspects facing trial at the Federal High Court sitting in Akure, Ondo State, who were apprehended during the 2023 UTME for registration and examination infractions, are to remain in detention following their failure to secure bail.

The suspects are to spend two more months in custody pending when the court reconvenes from its vacation which starts on Friday, 21st July, 2023, and is to end in October.

The registration impersonation suspects are: Timilehin Akinwale, Olayinka Mustapha and Peter Okereke, while Feranmi Adesuyi was arraigned for impersonation.

When the matter came up for hearing on Wednesday, 12th July, 2023, an official of the Joint Admissions and Matriculation Board (JAMB), Ms. Smith Oseinat Ayodele, told the Court that Feranmi Adesuyi was arrested for impersonation

WE SHALL SUSTAIN RULE OF ENGAGEMENT ON ADMISSIONS-COMMANDANT, NASFA

he Commandant, Nigerian Army School of Finance and Administration (NASFA), Lagos, Brig. Gen. Julius Osifo, has disclosed that his institution would sustain the extant rule of engagement as laid down by the Board, particularly with respect to admissions of fresh intakes into the school.

The Commandant made the disclosure in an interaction with JAMBulletin at the

sidelines of the matriculation ceremony for the 2022/2023 Academic Session held recently on the school campus in Apapa, Lagos State.

According to Brig. Gen. Osifo, the institution would never return to the era of underhand admissions characterised by the conduct of admissions outside the purview of the Central Admissions Processing System (CAPS) platform. He

workshop as the Board was one of the association's most valued partners.

Mr. Kanteh also expressed appreciation to the Registrar, Prof. Is-haq Oloyede and members of his management team for their warm reception in spite of the short notice aiven.

To underscore the activities of the Association, Mr. Kanteh also gave a brief presentation on WARIMA background, vision, mission and roles, stating that the association was established in 2006 with its Headquarters at the University of Ibadan, Oyo State, Nigeria.

He further disclosed that WARIMA provides research support to research managers across West Africa, and Africa as a whole through its collaborations with other regional research management associations such as the Central Africa Research and Innovation Management Association (CARIMA), Southern Africa Research and Innovation Management Association (SARIMA), East African Research and Innovation Management Association (EARIMA) and the world at large through its collaborations with the International Organisation for Research Management Societies (INORMs). He noted that through such collaborations, individuals

across regions could come together towards resolving challenges affecting their regions with the aim of seeking professional support from one another and through sharing of innovative ideas and experiences that would, in turn, proffer solutions to such challenges.

The WARIMA Chairman also underscored the importance of innovation noting that it requires a highly-specific skill set which frequently lies outside the experience of those chosen to lead research groups and institutions, regardless of their professional distinction.

He listed some of the factors affecting research and researchers in Africa as inadequate funding of research groups and institutions, poor documentation and interpretation, poor budgeting/accounting, poor reporting of research findings and lack of well-structured research management institutes, understanding of international best practices pertaining to research management and lack of collaboration with sister countries in West Africa, among others.

The Registrar, in his remarks, welcomed the WARIMA Chairman and members of his delegation to the Board and commended the

decision of the leadership of the association to hold one of its training workshop in Nigeria, and assured the delegation of the Board's continued support. He recalled that the last WARIMA Conference held in The Gambia was of immense benefit to the participants from the Board. He added that the Gambia conference was unique as it was held alonaside that of AWAU.

He also noted that the Board had sponsored ten participants, who were broken into two groups of five members each to attend both WARIMA and AWAU conferences respectively. He reiterated the commitment of the Board to achieving excellence by sponsoring its staff to attend and participate in local and international training workshops. As a pointer to the numerous benefits of such collaborations, he disclosed that during the just-concluded COREVIP conference in Namibia, he was informed of a training scheduled to take place in Lagos State, where six female members of staff of the Board would be screened out of which three would be selected to attend a training which would run for a period of three months.

He called on the leadership of WARIMA to look inwards into the possibility of collaborating with the leadership of AWAU, as both associations stand to benefit immensely from such a collaboration.

The Registrar noted with dismay the display of bias on the part of some research managers in canvassing for funds for some research groups and institutes. Elaborating further, he stated that some of these research managers were in the habit of prioritising certain fields and aspects of research over others, which, he said, often determined the organisations they approach for funding and urged WARIMA to look into it with a view to addressing such untoward behaviour.

FEW FACTS ABOUT JAMB

- The Joint Admissions and Matriculation Board (JAMB) was established for the general control of the conduct of matriculation examinations for admissions into all universities, polytechnics, monotechnics, colleges of education and (recently added) Innovation Enterprise Institutes (IEIs).
- Section 5 (2)of the ACT establishing the Board provided as stated: For the avoidance of doubt, the Board shall be responsible for determining matriculation requirements and conducting examinations leading to undergraduate admissions and also for admissions to National Diploma and the Nigerian Certificate in Education courses, but shall not be responsible for examinations or any other selective process for postgraduate courses and any other courses offered by the tertiary institutions. In the implementation of this section, there is always a synergy with the National Universities Commission(NUC), the National Board for Technical Education(NBTE) and the National Commission for Colleges of Education(NCCE) with the endorsement of the National Council on **Education(NCE).**
- In exercising this power, the Board is always guided by admission guidelines approved by the Policy Meeting under the Chairmanship of the Hon. Minister of Education with all Heads of Tertiary Institutions and other stakeholders in attendance.
- Since the inception of the Interim Joint Matriculation Board 1 Examination (IJMBE), JAMB appoints moderators for all its questions as well as the grading of candidates scores. It has always done this without failing to still accommodate 'HSC' within the current 6-3-3-4 system. The National Council on Education(NCE) guidelines for the Joint Universities Preliminary Examinations Board (JUPEB) also endorsed the practice for JUPEB.
- The Joint Admissions and Matriculation Board shall continue to operate within its laws.

INNOVATIONS IN THE UTME AND A CALL FOR UNDERSTANDING

It will be recalled that the Board has gradually upgraded its operational processes since 2017, and as is usual with change, it came with some challenges including resistance. Given public support and understanding, the Board since 2018 has reached the cruising level. However, there is always room for improvement and the Board has decided to move to the next stage of its technological transformation.

The next stage requires all hands to be on deck as we take some crucial steps. The Board has instituted some measures which are to be deployed during the 2023 UTME exercise. Despite the fact that the innovations have been tested and certified, yet it is not unlikely that some hiccups might spring up when the new technology is deployed live and nationwide. We therefore solicit your support and understanding as we promptly address any unforeseen circumstances. Hardly can there be growth without audacity and courage.

One major feature of the new dispensation is that no examination would be allowed to take place after one hour of its scheduled start time because the Board has discovered that some of the problems reported at the centres are contrived to delay the commencement of a session in some centres with a view to securing undue advantage for the delayed candidates.

Consequently, any session that, for whatever reason(s), could not take-off within one hour of its schedule is automatically rescheduled. When such occurs, affected candidates are expected to file out of the examination hall into the waiting hall and await the new scheduled time and place which most

likely would be the same or following day. Candidates are expected not to disrupt subsequent sessions but to simply await information on reschedule. Parents have constituted major intrusion into the examination process. While we appeal for parents to keep-off the examination venues, we would not hesitate to sanction the candidates and (parents) whose parents obstruct the smooth running of the centre.

The rescheduling does not permit a candidate who was initially marked absent during the screening to be part of the rescheduled session since the questions meant for such absentees have been withdrawn and not available for the rescheduled session.

In addressing possible rescheduling, an extra session has been created for every centre on every examination day.

ABIA STATE COORDINATOR MEETS PROPRIETORS OF CBT CENTRES

n line with the Board's commitment to quality service delivery, the Abia State Coordinator of the Joint Admissions and Matriculation Board (JAMB), Mr. Johnson Adebiyi, on Tuesday, 11th July, 2023, met with proprietors of computer-based test centres in the State.

The meeting, which was held virtually, had in attendance all the CBT centres in the State as well as the Unit Heads of the State Office, and was organised to address the underperforming areas identified in the Key Performance Metrics (KPMs) Dashboard for accredited CBT centres in the 2nd Quarter of 2023 and, most importantly, to expand the conversations on innovative ways of delivering quality services against the backdrop of the present economic realities in the country. According to Mr. Adebiyi, the Board

is not oblivious of the tough extant operating conditions but urged them to do their best for the fatherland.

Earlier, the State Coordinator had commended the centre proprietors for their excellent service delivery during the just-concluded 2023 UTME particularly in ensuring the conduct of flawless examinations in the State. He explained that it was in a bid to ensure the continuation of same that the State Office had found it expedient to synergise with them on how to incorporate the best cost-effective strategies into their operational processes without putting extra burden on candidates. The State Coordinator stated that since the primary aim of the interaction was to explore ways of lessening the financial burden on CBT centres without diminishing their operational efficiency, he urged

centre proprietors to embrace alternative sources of energy such as solar, inverter, and other costcutting measures, the use of laptop computers in place of desktops

He also advised the CBT centres to take advantage of the Board's decision to devolve some registration activities, which were hitherto restricted to the Board's offices, such as Sandwich, Part-Time, NOUN, and Distance Learning to improve on their revenue generation as well as establishing two additional registration outlets in the State as allowed by the Board. The virtual meeting was brought to an end with the centre proprietors pledging to embrace the fresh insights given by the State Coordinator to stay afloat while adhering strictly with their rules of engagement.

ADVISORY ON PROCEDURE FOR EMERGENCY TRANSFER OF RETURNEE NIGERIAN STUDENTS INTO **NIGERIAN UNIVERSITY SYSTEM IN TIME OF CRISIS**

Please find below the procedure for processing transfer of Returnee Nigerian Students into Nigerian University system in time of crisis:

- 1. A prospective student travelling abroad for undergraduate studies normally registers (document his/her travel) with the Federal Ministry of Education (FME) and obtains a Document ID. It is called "Notification to Study Abroad". In case of crises such registration becomes helpful.
- 2. Anyone who did not but has now become a returnee who is desirous of transfer into a Nigerian University must do a retroactive registration with the Federal Ministry of Education as follows:
 - Go to FME website www.education.gov.ng
 - Go to attestation of academic documents or http://.ess.education.gov.ng
 - Tick the certificates you want to evaluate (Tick your highest qualification in Nigeria to enable you pick a date)
 - Pick a date
 - Make payment via remittal RRR code
 - Print Appointment Slip
 - Go to FME Revenue Unit 2nd floor
 - Go to 8th floor Evaluation Accreditation Division with original copies of your credentials base on your Date of Appointment

- 3. Returnee Student visits Returnee Application page on IBASS from JAMB website: www.jamb.gov.ng
- 4. In the IBASS page, the Returnee Student uploads the registration slip obtained from the FME and then completes the Returnee Transfer Personal data:
 - a. Name
 - b. NIN
 - c. Telephone Number
 - d. Active e-mail address
 - e. Current University
 - f. Country and City of Study
 - g. Programme
 - h. Year of Entry
 - i. Current Level of Study
- 5. Returnee Student selects intended University of Choice and Programme.
- 6. Returnee Student uploads scanned copy of the following documents:
 - a. Current University Admission letter;
 - b. Transcript/Student Semester Results;
 - c. Data page of International Passport; and
 - d. Sworn Affidavit (confirming the genuineness of information supplied and that insincere or false information shall lead to withdrawal from studies and/or of certificates (in the event of issuance). Prosecution may also follow.
- 7. Returnee Student clicks SUBMIT button, which now sends an email to intended University of Choice for Request for Application to Apply for Inter-University Transfer.

- 8. Notification page for successful request is loaded and presented on the screen by IBASS System.
- 9. Returnee Student gets a notification email and SMS for his/her application request sent to the intended University of Choice.
- 10. Student's University of Choice gets an IBASS mail of the Student's Request for Application to Apply for Inter-University Transfer
- 11. Intended University evaluates Student's credentials for possible consideration.
- 12. If the Intended University of Choice is satisfied/unsatisfied with the credentials presented by the Returnee Student, a notification is sent on JAMB-IBASS-mail for Qualified/Unqualified for consideration.
- 13. Qualified Returnee Student is directed via the email and SMS to approach any JAMB Office (in person) to complete the Inter-University Transfer Application.

Note that the process is tracked by JAMB, NUC and the candidate as follows:

- (a) Submitted
- (b) Being reviewed by the University
- (c) Successful/Unsuccessful
- 14. The intended University of Choice then follows the Advisory on <u>Inter-University</u> <u>Transfer of Students earlier sent to the institutions in 2019</u> (see attached).

ADVISORY ON PROCEDURE FOR APPLICATION FOR FOREIGN INTER-UNIVERSITY TRANSFER FOR STALITES (NOT FRESHERS)

Please find below the procedure for application for foreign inter-University transfer for Stalites:

- 1. The proposed institution sends a list of all candidates (not Freshers) for foreign Inter-University transfer to State JAMB Office with a letter of indemnity.
- 2. The proposed institution directs each candidate to State JAMB Office to create his/her profile on efacility platform (Candidate not on the list earlier sent by the proposed institution would be rejected by the State JAMB Office and cannot process any application on the system).
- 3. At State JAMB Office, the candidate fills the INTER-UNIVERSITY TRANSFER APPLICATION FORM FOR STALITES (NOT FRESHERS) FROM FOREIGN UNIVERSITIES online which would be available only at the State JAMB Office (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- 4. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her Current and Proposed Institutions for the signature of the Heads of the Institutions to indemnify JAMB on the accuracy of the information provided by the candidate. The form is to be endorsed first by the current institution.
- 5. The Proposed Institution sends the endorsed and indemnified form to the Coordinator of the State JAMB Office.
- 6. The form is uploaded from the State JAMB Office to the Headquarters and made available to the efacility platform for processing.
- 1. If the application is approved, the candidate is notified through his/her email.
- 2. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS

- All applications of admissions to First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc., must be processed ONLY through the Joint Admissions and Matriculation Board (JAMB).
- No Institution should advertise or sell "application forms" for admissions into the programmes. Institutions should advertise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
- The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

ADVERTORIALS

- Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
- It should be reiterated that no Institution should advertise or sell "application forms" for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
